RULES AND REGULATIONS PORTFOLIO REVIEW PHOTOGRAPHERS AND PROJECTS

A viewing for photographers of all nationalities and ages with their own projects or co-authored projects that present a photographic proposal consisting of more than one image with a specific conceptual framework. Both the image and the underlying concept of the current photographic project will be valued. The photographer must send through the form a maximum of 10 images of the project and a statement of the project to be assessed by the selection committee.

APPLICATION AND AGREEMENT

Call for entries until April 22nd through the web application form. All applications must be accompanied by payment by credit card of the registration fee of 37€ (which will not be reimbursed if your project is not accepted).

The registration of the project gives the possibility free entrance to the fair from 26th to 29th October 2023.

Online fair

Stand of 19 linear metres in viewing room format that allows direct sales and contact as well as high quality zoom and immersive experience.

Where is it? Art Photo Bcn online platform

When? Installation from 1 to 20 July

Opening to the public from 15 September to 30 November

Card sales through the online platform a cost of 3% of the prize.

RULES OF PARTICIPATION IN THE ONLINE FAIR.

1. Rules of participation and selection of works

Photographic work will be presented in the format suitable for exhibition and marketing. It will not be allowed to exhibit other visual arts such as painting, sculpture or manufactured materials which do not include the image in its wide range of reproduction possibilities. It is compulsory that all works must be accompanied by their corresponding certificate of authenticity in the case of limited editions.

2. Cancellations

In the event that Art Photo Bcn cannot be held in person within the year 2023 for reasons beyond the control of the organization, an online presentation of the event will be available through the appropriate platform for the correct development of the viewings. The participation in the online platform will continue as normal.

3. Grounds for exclusion

Failure to comply with the rules of participation.

Submission of false works or works of unlawful origin, as well as damaged works or works whose authorship is not acknowledged by the author.

Failure to respect the timetable of the session.

4. Promotional material

Insertion of the photographer's project in printed and online promotional material in printed and online material is subject to the conformity of the presentation of the materials.

Photographers must send to fotografos@artphotobcn.com before 1 June

- Exact name of the photographer and project as would like to be featured
- 3 images in high resolution (300 dpi) in jpg format of 2 MB in jpg format.
- Final text of the project.

Each photographer will have his or her own space on the online platform. The information included in the section will be validated by the photographer on the basis of the information provided in the registration form registration as well as in the promotional materials email.

Photographers guarantee to Art Photo Bcn that the images and content that they provide for web dissemination and distribution to the media do not infringe the intellectual property rights of third parties, and that they have the authorisation of the authors or those who hold such intellectual property rights. The photographer must hold Art Photo Bcn harmless against any judicial or extrajudicial claim derived from the non-fulfilment of the present stipulation, assuming in this situation any compensation or expenses that may be originated to Art Photo Bcn (including those of lawyer and solicitor, even if it is not solicitor).

5. Data protection

The personal data provided by the photographer as a result of the contractual relationship maintained between both parties will be included in a data file owned by Art Photo Bcn, and maintained under its responsibility. The purpose of this file is the compliance and proper management of relations with exhibitors at the fair. The photographer may at any time exercise the rights of access, rectification, cancellation and opposition with respect to their personal data, by means of written communication addressed to Art Photo Bcn.

6. Legislation and jurisdiction

By the mere fact of applying to participate in Art Photo Bcn X edition, it is understood that the present Rules of Participation in the Portfolio Review are understood to be accepted in full. This Agreement is governed by Spanish law. The Rules of Participation are in English and Spanish. In case of discrepancy of the two versions, the Spanish version shall prevail.

The Parties, expressly waiving their own jurisdiction, expressly and irrevocably submit to themselves to the Courts and Tribunals of the city of Barcelona for any questions that may arise from the interpretation, validity or fulfilment of this Contract or of any agreement subject to it.
